#### Share your views of access to the contraceptive pill



The Medicines and Healthcare products Regulatory Agency (MHRA) wants patients' views on how people get contraceptive tablets and if it would be good to make getting them easier.

It is looking for people to take part in a meeting to discuss this who:

- Have taken any tablets for contraception
- Are willing to reflect personal experiences about obtaining contraceptive tablets from doctors, sexual health clinics, pharmacies, or other places
- Are happy and confident communicating with a diverse range of people
- Are willing to complete a confidentiality declaration form and a conflict of interest form if you are shortlisted for the meeting.

You do not have to have a medical, nursing or pharmacy qualification or background to take part.

The meeting is on Thursday 10<sup>th</sup> November 2022 at 10am. It will take place remotely on MS Teams and last for about 3 hours. There will be other members of the public, and healthcare professionals including pharmacists and nurses attending. Participants will be offered offer reimbursement for their attendance at the meeting.

The MHRA will contact shortlisted participants by Friday 7th October at the latest. If you are invited to attend, you will be asked to fill out a conflict of interest and confidentiality declaration form. Due to the impartial nature of advice sought, conflicts of interests may prevent your participation.

The MHRA\_is responsible for regulating all medicines and medical devices in the UK by ensuring they work and are acceptably safe. This meeting is part of the MHRA's reclassification process. You can read more about the reclassification process and how stakeholders are involved <u>here</u>.

Help prioritise research



Earlier in the summer the <u>Incubator for Clinical Education Research</u> distributed a survey to gather opinions about priorities for clinical education research.

#### Wales consults on HIV plan



The Welsh Government is consulting on an HIV Action Plan for Wales.

It wants to hear the views of people living with HIV and the wider public about the plan. The consultation has a number of questions for respondents to consider, but you can feedback in a format that's acceptable to you, including video clips or writing your thoughts in a language you feel comfortable using.

The consultation will run until 14<sup>th</sup> September. The Government aims to publish the final plan later in 2022.

#### From the helpline Patient transport



Cathy<sup>\*</sup>, who lives in the North West of England, rang our helpline to get advice on patient transport to a hospital appointment.

Cathy isn't very well, doesn't drive, wouldn't be able to get to the hospital using public transport, and doesn't have anyone to drive her to the

#### appointment.

Some patients are eligible for free patient transport services although this isn't available in all areas. To find out if you're eligible and how to organise it, patients need to speak to their GP or the healthcare professional who referred you to hospital.

Our adviser established that Cathy's GP would have to order patient transport for her, once it had been established that she was eligible for the service.
