Plans unveiled yesterday by Secretary for Health and Social Care, Dr Thérèse Coffey, about how she will champion patients are very welcome.

We were pleased to see the focus on improving access to primary care, reducing waiting times in the handover of patients from ambulances to A&E,

and providing patients with more information about their general practice's performance, in the Government's plan, which is called Our plan for patients.

But long term stable funding for social care and a long term workforce strategy for health and social care are needed if this plan is to work.


The <u>National Hip Fracture Database (NHFD)</u> has published resources for patients with hip fractures and their carers.

The resources are available online to download from the Royal College of Physicians's website. There are guides for family and carers, hip fracture treatment, and recovery after a hip fracture. Follow the link in the button below to access the information.

The National Hip Fracture Database (NHFD) is a clinically led web-based audit of hip fracture care and secondary prevention in England, Wales and Northern Ireland. It collects data on all patients admitted to hospital with hip and femoral fractures aiming to improve their care through auditing, which is fed back to hospitals through targeted reports and online reporting.

## From the helpline Next of kin and advance care planning



Mary\*, who lives in the South West of England, called our helpline to find out how to change who is listed as her next of kin in her medical records.

Mary's son is currently listed as her next of kin, but she wanted to change it to her partner because she was concerned her son may not carry out her wishes in the event she wasn't able to make her wishes known. Our adviser told her how to update her information by contacting her GP surgery and shared the link to our information online about next of kin.

Our adviser also suggested that Mary, who is 84, consider putting in place an advance decision and explained how it would ensure her wishes were carried out if she was unable to make or communicate her wishes in the future. We also have information on setting up advance decisions on our website.
